What Should My Camper Bring?

Our primary guideline for preparing your camper is to remember that your child will be outside all day. They will be playing in the summer sun with other campers around them. Please make sure what your camper wears is camp or school appropriate. Camp is a G-rated experience so everyone can feel welcome.

Footwear

Closed toe shoes that are well-worn in should be worn at all times even on their way to the pool. Please do not send your child to camp with open toed shoes, inadequate foot wear like brand new shoes, flip flops or sandals. Old sneakers are the best choice. It is just as important for shoes to be well-worn in, brand new shoes cause blisters and are uncomfortable at camp. Campers will be required to wear proper shoes at all times unless they are in the pool.

Clothes

Clothes should be just like footwear; well-worn in and comfortable. Brand new clothes may make your camper apprehensive about joining in on activities that require them to get their hands dirty. The chances of them losing things are always possible, so there is no need to dress your camper in new clothes or bring anything expensive to camp. In addition to this, it is important that your child is able to put their clothing on by themselves (bathing suits, etc.). **Extra clothes are great for your camper to have in their backpacks. Extra shorts, socks and underpants would be recommended for your camper to bring to camp.** Pro tip: always bring a raincoat.

Swim Clothes

Swimsuits and towels need to be brought to camp on swim days, those are **(Wednesdays & Fridays)**. Campers are not allowed to wear regular clothes or gym shorts into the pool. Boys need to bring trunks with a mesh lining inside. One-piece swimsuits are recommended for girls. Swimsuit must be approved by Parks & Recreation Pool Staff.

Other Items

Every camper needs to bring a backpack to camp. Please pack sunblock and bug spray each day. Please do not bring aerosol can bug spray or sunblock, instead bring the pump bug spray or bug bracelet and lotion sunblock. **Campers bringing personal items like toys are not permitted.**



No Electronics of Any Form or Function is Allowed.

Electronics can get broken, wet or lost at camp. Our staff will try to obtain any electronic items at the beginning of the day. However, Parks & Recreation cannot be held liable for broken, stolen or lost items.

- **Backpack**
- **Worn in closed toe shoes/sneakers**

Pool Days

Campers need to be prepared for pool days. Pool days are **Wednesdays and Fridays**. It will be helpful to always pack a swimsuit for your camper. Always pack a plastic bag for campers to put wet clothes in after the pool.

Special Events

Special events will be planned throughout the different sessions of camp. Camp Staff may ask their campers to bring special items like cowboy hats. However, your camper will still be able to participate in all activities if they forget to bring items for special events. We will also have outside visitors coming to do additional programs. Campers will remain in Bob Noble Park for the majority of their camp experience.



Camp Policies & Procedures

Inclement Weather

Expect camp to meet if there is a chance of showers. We will have an indoor space if conditions worsen with rainy day activities planned. The Camp Director and Camp Staff will constantly be watching for signs of severe storms and watching weather forecasts. Severe weather procedures will be followed in case of a severe storm. The Noble Park Pool, Arts & Crafts Building, & Robert Cherry Civic Center will serve as our severe weather shelters if needed. The Paducah Parks & Recreation Staff will contact parents by **Phone or Group Me** if camp ends early due to extreme weather.

Please call our cancellation line at 270-444-8621 for cancellation information if morning weather conditions are severe. The line will be updated at least thirty minutes before the start of camp.

Medication at Camp

Medications prescribed by doctors that are to be taken on a regular basis may be brought to camp each day in the original containers with dosage and frequency clearly stated on the original labels. All medications must be placed in a plastic Ziploc bag labeled with the name and age of your child. Medication such as antiseptics and acetaminophen should not be brought to camp. Prescribed medication will be kept by staff in their first aid kits. Medications **must be administered by the child or the (Parent/Guardian) can arrive at camp to administer** at the appropriate time. Camp Staff will carry antiseptics and other supplies in their first aid kits.

In the event of a medical emergency; Camp Staff will call 9-1-1 and follow all recommendations set forth by 9-1-1 dispatch. Any and all medications will not be administered by staff unless instructed to do so by 9-1-1 dispatch and only with parent/guardian approval on the Medical Authorization Form.

Fill out the Medication Authorization Form if your camper will need medications at camp.

Summer Food Program

Breakfast and lunch will be provided through the Paducah Public Schools Summer Food Program. A calendar of scheduled lunches will be available on request. Please note any food allergies on the registration form. Personal snacks are allowed and must be kept in their backpacks.



Pick Up and Drop Off Procedures

The Pick Up and Drop Off Authorization Form must be completed and on file for each camper before they arrive at camp.

Pick Up and Drop Off is at Shelter 16 in Bob Noble Park.

Pick Up Procedure

All guardians and authorized persons must show a **valid photo ID** before signing out their camper. Persons picking up campers without a **valid photo ID** will not be allowed to leave with campers. Also, **Persons will not be allowed to leave with a camper if they are not on their Pick Up and Drop Off Authorization Form.** Campers are not allowed to sign themselves out. **Authorized persons must be at least 18 years of age.**

Campers must be signed out before leaving camp for the day. **Do not leave without your camper signing out with Camp Staff.**

Please contact the Parks & Recreation Office directly involving court orders and/or custody conditions. This will require special attention by Camp Staff.

Pick Up and Drop Off Times

Dropping off campers must be no earlier than the start of camp (**7:30a.m.**). All campers must be promptly picked up at the end of the camp day (**No later than 5:30p.m.**). Camp Staff will not be available to stay before or after with your child. Call the Parks & Recreation Office if an emergency situation arises.

Changes to Pick Up and Drop Off Authorization Form

The Pick Up and Drop Off Authorization form cannot be altered. The original authorizer must complete a new form and turn it in to the Parks & Recreation Office. **Any changes, additions or deletions to the form warrants completion of a new form.**

Early Pick Up

Please notify Camp Staff in advance of early pick-up times.

Campers must be signed out before leaving camp for the day. Do not leave without your camper signing out with Camp Staff.



Behavior and Discipline Policies

All parents and guardians must read and review these Behavior and Discipline Policies with their camper before they arrive at camp. You and your camper are required to sign and date the Behavior and Discipline Policies section of the **Camp Forms Acknowledgement & Agreements to confirm they are fully aware of their expectations.**

Paducah Parks & Recreation works hard to provide an environment that is fun, educational, recreational and safe for all of our campers. Therefore, we will not tolerate dangerous or disrespectful conduct from our campers. If necessary, we will sit campers out during games, activities and pool time.

Examples of Unacceptable Behavior

- Physical or mental abuse of other campers, staff, or oneself (Bullying)
- Physical altercations (kicking, hitting, punching, pushing, throwing items, etc.)
- Leaving designated areas without permission
- Destruction of property
- Profanity and/or disrespectful language
- Threatening violence to other campers or staff
- Jeopardizing the health or safety of themselves, other campers or staff
- Refusing to follow instruction, or guidelines are given by staff
- Throwing trash on park grounds

Daily Report Forms may be sent home with a child to notify parents of disciplinary actions taken at camp and requested action of parents/guardians to address the behavior with their child.

The above list is not all encompassing. Paducah Parks & Recreation Staff will use their judgement to determine what behaviors warrant consequences.

Disciplinary Policy

Discipline for unacceptable behavior will be determined by Camp Staff and will depend on the specific situation. Certain behaviors will warrant suspensions and/or dismissal from the Summer Camp Program. Suspensions and length of suspensions will be determined based on the severity of the action of the camper; and are up to the discretion of the Paducah Parks & Recreation Staff. Suspensions may require a camper to be sent home early from camp. Refunds will not be distributed to campers suspended from camp.
